STREAMLINE RECORDS MANAGEMENT WORKFLOWS

ADD THE INCIDENT ID TO DIGITAL EVIDENCE

CommandCentral Evidence intelligently scans the digital evidence metadata and recommends the Incident ID and nature based on the capture date, time or officer. This saves officers valuable time because the most relevant incidents IDs are listed first, instead of having to remember or search for the appropriate record. If you don't see the right Incident ID, you can always add one manually.

INCLUDE DIGITAL EVIDENCE IN THE CASE FOLDER

Once tagged, digital evidence files are automatically made available within the Flex Records Law Incident and organized by source for streamlined review of all case-related information in one place. It's easy to preview files within the Law Incident, or open the file in CommandCentral Evidence for more advanced digital evidence management capabilities.

UPLOAD EVIDENCE WITH A MOBILE APPLICATION

Instead of a DSLR camera, capture high quality pictures, videos and audio with the CommandCentral Capture mobile application. All evidentiary data is isolated from personal data, making it inaccessible for tampering by other apps so you never need to subpoena devices. Captured media is tagged with the Incident ID in the field and automatically uploaded to both CommandCentral Evidence and the Law Incident for immediate use.

DICTATE YOUR PRIMARY NARRATIVE

Save time by dictating your primary narrative in the field from the CommandCentral Capture mobile application, which is included with your CommandCentral Evidence license. The narrative is automatically transcribed and made available within both the Flex Records Law Incident and the CommandCentral Consolidated Record View.

ELECTRONICALLY SHARE THE CASE

Integrating Flex with CommandCentral Evidence gives you the ability to securely share cases electronically with judicial partners. This is done through the CommandCentral Consolidated Records View, which includes the data and attachments from Flex Records in a user-friendly, view-only Case View for prosecutors. Prosecutors are given access to the CommandCentral Case Manager, which makes it easy to search, organize, and receive updates on shared case packages even from multiple agencies.

HOW DO I GET EVIDENCE INTO THE LAW INCIDENT?

Including digital evidence in the Law Incident is easy. There are three options when it comes to uploading digital evidence to your records management system:

AUTOMATIC EVIDENCE UPLOAD

CommandCentral Capture images, video and audio files are tagged in the field and automatically uploaded to CommandCentral Evidence over cellular or a stable Wi-Fi connection. Once uploaded to CommandCentral Evidence, these files appear in the Flex Records Law Incident.

MANUAL UPLOAD TO THE LAW INCIDENT

Any attachments uploaded to the Law Incident are automatically stored in CommandCentral Evidence to save on-premises storage space. While these files remain available for review within Flex Records, CommandCentral Evidence simplifies data management, such as setting the retention policy, verifying the chain of custody, synchronizing playback of multiple video streams, and creating shorter clips of longer content.

MANUAL UPLOAD TO COMMANDCENTRAL EVIDENCE

Files can also be manually uploaded to CommandCentral Evidence. Once tagged with the Incident ID, these files are automatically viewable in the Flex Records Law Incident for a more streamlined view of all case-related information in one place.
